**ELECTOR REGISTRATION** (for voting day registration)

Registration of electors for this election will take place at the time of voting. You will be required to make a declaration that you meet the following requirements:

- 18 years of age or older
- Canadian citizen
- resident of BC for at least 6 months immediately preceding voting day
- resident of OR registered owner of real property in the jurisdiction for at least 30 days immediately preceding voting day, and
- not otherwise disqualified by law from voting.

PLEASE NOTE that electors, when registering to vote, must produce **two pieces of identification (at least one with a signature)** to prove both residency and identity of the elector.

Acceptable forms of identification include:

- a. a BC Drivers Licence;
- b. a BC Identification Card issued by the Motor Vehicle Branch;
- c. an Owner's Certificate of Insurance and Vehicle Licence issued by ICBC;
- d. a BC CareCard or BC Gold CareCard;
- e. a Ministry of Social Development & Economic Security Request for Continued Assistance Form SDES8;
- f. a Social Insurance Card issued by Human Resources Development Canada;
- g. a Citizenship Card issued by Citizenship and Immigration Canada;
- h. a real Property Tax Notice
- i. a Credit Card or Debit Card issued by a savings institution, or
- j. a Utility bill for electricity, natural gas, water, and telephone service or cable TV service.

**Non-resident property electors** must produce, in addition to the two pieces of identification, and if applicable, the written consent from the other registered owners of the property. If there is more than one registered owner of the property, only one of those individuals may register as a non-resident property elector.

Proof of property ownership (e.g. Certificate of Title, Property Tax Notice) will be required.

**PLEASE NOTE that in accordance with Section 39(4) of the *School Act*, "a person must not vote more than once in a trustee election for any one school district".**
