Position: Early Childhood Educator (ECE)

POSITION SUMMARY: Under the direction and supervision of the District Principal of Early Learning and Child Care (ELCC) or designate, the Early Childhood Educator (ECE) works in partnership with early years educators and school staff to enhance children's cognitive, physical, social, and emotional benefits. This position is responsible for supporting the practices of the BC Early Learning Framework, including the pedagogy of listening, critical reflection, collaborative dialogue, and pedagogical narration to enhance learning in early childhood learning environments. Knowledge of pedagogical practices for play-based learning and early childhood education is essential.

POSITION DUTIES AND RESPONSIBILITIES:

- Plans, coordinates, and leads developmentally appropriate play-based early learning experiences.
- Establishes positive relationships through critical reflection and invites collaborative dialogue with the district ELCC team, school staff, community partners, families, and children.
- Supports the transition of information between children, families, and classroom colleagues.
- Collaborates with early years educators, and other school staff to create a seamless transition for children moving between the school day and licensed child care programs.
- With colleagues, plans and maintains a learning environment that promotes a pedagogy of listening to enhance the health, security and well-being of children.
- Collects traces of practice to enhance pedagogical narration.
- · Attends meetings as requested.
- Supports district ELCC initiatives and projects, including after-school.
- Supports budget preparation and purchase and maintenance of supplies and materials.
- Maintains the confidentiality of sensitive information seen or heard.
- Understands and acts in accordance with relevant policies and procedures from the school, district,
 Ministry of Education and Child Care and WorkSafeBC.
- Completes ongoing professional development and maintains ECE Certificate to Practice.

REQUIRED EDUCATION AND EXPERIENCE:

- Grade 12 plus the successful completion of a basic early childhood education training program recognized by the ECE Registry.
- Current Early Childhood Educator's Certificate to Practice from the BC government's ECE Registry.
- One (1) year of recent experience working as an ECE in an early learning or child care setting, inclusive
 of 500 hours of work experience performed under the supervision of a Canadian certified ECE.
 Equivalent experience working with school-aged children may be considered.
- Valid Child Safe first aid certificate.
- Clear criminal record check and evidence of compliance with the province's immunization and tuberculosis control programs as required by the Child Care Licensing Regulation.

REQUIRED KNOWLEDGE, SKILLS, AND ABILITIES:

- · Proven ability to communicate effectively, both verbally and in writing.
- Proven organizational and planning skills.
- Proven understanding of, and commitment to quality early learning programming and a demonstrated knowledge of the BC Early Learning Framework.
- Proven ability to work effectively with a variety of parents, children, staff, volunteers, professionals, and community members using courtesy, tact, and discretion to gain cooperation and coordinate activities or programs.
- Proven ability to use developmentally appropriate restorative practices to build relationships with children in early learning programs and create and inclusive learning environment that honours children as strong, capable in their uniqueness and full of potential.
- Eligible for membership with the Early Childhood Educators of BC (ECEBC).

- Understanding of the ethics of Early Childhood Education as described in the ECEBC Code of Ethics.
- Strong problem-solving and organizational skills and the ability to work with minimal supervision.
- Possess the personality, ability, and temperament to provide care and mature guidance to children.
- Knowledge of Truth and Reconciliation and its application in Early Years settings and a commitment to the Truth and Reconciliation Calls to Action.

Other qualifications, skills and abilities may be required to meet Ministry or Childcare Licensing requirements or terms of the program. This description contains the elements necessary for the identification and evaluation of the job. It is not an exhaustive list of the duties to be performed. Duties not listed should not affect the evaluation.
